Specification of Automatic Tissue Embedding Centre

- Should be a fully programmable, automatic On/ Off control, two-console unit, one heated paraffin dispensing unit and another Cryo console with cooling plate.
- The system should work on 220-240 V, 50 Hz. Should use CFC free gas and must have ISO 9000/01/02 certification or European EC certificate.

I. Paraffin Dispensing Unit

- Capacity of paraffin tank: min 3 litres
- Capacity of Thermal Chambers for storage of molds: min 1.8 litres or approx. 100 cassettes
- Temperature range of Paraffin tank: approx. 50-70 deg C
- Temperature range of Thermal Chamber: approx. 50-70 deg C
- Temperature range of Hot plates & forceps wells: approx. 50-70 deg C
- Connection for Electrically heated forceps
- Gravity feed paraffin dispenser
- Optional foot switch for control of paraffin flow.
- Large warm working surface on either side for min 10 cassettes on each side.
- Control panel must have LCD display and easy navigation through the menu with help of simple touch key buttons.
- Optional magnifying lens adjustable in any position

II- Cold Console

- Capacity of freezing up to 70 standard cassette molds.
- Temperature of cold plate either constant at -5 deg C or a range of: 0 to -12 deg C, adjustable in steps of 1 deg C.
- Compressor to be extra quite to reduce noise fatigue.

- Credibility: Manufacturers should demonstrate a record of successful installations in similar reputed institutions/ research centers across India. A comprehensive list of prior installations should be provided.
- Two years comprehensive warranty for entire system.
- The post warranty CMC for another three years should be quoted separately. The price comparison shall be taken into account with the basic cost of the equipment with 2 years warranty and post warranty CMC for three years. Failure to comply this condition entails rejection of bids.
